## **TOURNAMENT RULES & INFORMATION**

(Please read carefully)

1. This tournament is USBC certified. This tournament is open to members of the Gulf Coast USBC and past Gulf Coast USBC Life Members. Gulf Coast USBC Association membership may be purchased at the time of the tournament.
2. Date and time preference will be given as entries are received, except preference will be given to Hall of Fame members for Squad 2.
3. Re-entries are permitted. Bowlers can only cash once in singles and can cash as often as possible in doubles provided partner is different. In team event, two members must be different in order to cash more than once.
4. When a bowler competes more than once, their first appearance in each event shall count toward their All Events.
5. Team captains should be present thirty (30) minutes prior to their scheduled shift.
6. Lineup changes should be requested at least 30 minutes prior to the entrants' scheduled bowling time.
7. The scoring computer printouts will be the official score. Errors in scoring must be reported within one hour after the series has been bowled.
8. Prize fees will be returned 100%.
9. All prizes will be awarded on a handicap basis except the Scratch Option entry winners. The cash prize ratio will be 1 in 6 entries for all handicap events and 1 in 12 for all scratch events.
10. Handicap will be based on 90% of the difference between individual average and 210.
11. Entrants will use their highest published USBC average (minimum 21 games) from the previous season. If entrant does not have a published average from last season, they may use their highest USBC league average established in a sanctioned (summer) league that started after 15 March. If the entrant does not have a published or established summer league average, they shall use their current USBC (minimum 21 games) highest average as of the time they enter this tournament. If none of the above applies, the entrant will bowl scratch.
12. Rule 314, no fees returned, does apply.
13. Rule 319a2, ten (10) pin increase in average rule for this tournament, does apply.
14. Rule 319a3, bowlers are responsible for verifying their own averages, does apply. Failure to use the correct average shall disqualify score if submitted average is lower than the correct average thereby resulting in more handicap. Prize winnings shall be based on the submitted average if it is higher than the correct average. Corrections in averages may be permitted up to completion of the first game of the series.
15. Rule 319d, reporting of prize winnings, does apply.
16. Rule 322a, concerning the handling of late bowlers, does apply.
17. Rule 324b, concerning substitutions, does apply.
18. Any rules not covered on this entry will be referred to the USBC Rulebook.
19. Only one PBA bowler per team and only one PBA bowler per doubles team allowed.
20. The Tournament Director and/or Board of Directors of Gulf Coast USBC Association reserve the right to accept or reject all entries and will decide all questions or disputes arising in the tournament and their decision will be final, unless an appeal is made in accordance with the USBC rules.
